- e. policy reinstatement.

- 8. Perpetual Premium Discount under Table A will continue to be applicable upon renewal of the applicable Qualifying Product(s), where applicable.
- 9. Premium Discount is not transferrable or exchangeable for cash, credit or any other goods and services.
- 10. Manulife reserves the right to replace the Premium Discount with item(s) of similar or other value without prior notice to you.
- 11. If you cancel any policy of Qualifying Product(s) within the 14 days' free-look period, or if the policy lapsed or is surrendered within 12 months from the policy issue date, Manulife reserves the right to recover the amount equivalent to the Premium Discount(s) that have been awarded to you in any manner at its sole and absolute discretion.
- 12. Manulife is not liable for any direct and indirect losses, claims, demands, expenses and/or other liabilities, whatsoever in relation to or arising out of or in connection with this Campaign.
- 13. You consent under the Personal Data Protection Act 2012 of Singapore to the collection, use, and disclosure of your personal data by / to Manulife and such other third parties as Manulife may reasonably consider necessary for the purpose of this Campaign.
